INTRODUCTION

Integrated Development Planning is a process through which municipalities prepare a strategic development plan for a period of five years. The Integrated Development Plan (IDP) is in principle a strategic planning instrument, which guides and informs all planning, budgeting, management and decision-making in the municipality and is linked to the term of office of councilors.

In accordance with Chapter 5 of the Local Government: Municipal Systems Act, 2000, Act 32 of 2000, all municipalities have to undertake a strategic developmentally-oriented planning process to achieve the objects for Local Government as set out in the Constitution of the Republic of South Africa, 1993, Act 200 of 1993 (sections 152 and 153).

Municipalities have been awarded major developmental responsibilities under the Constitution to ensure that the quality of life of all citizens is improved. This includes the provision of basic services, creation of jobs, promoting democracy and accountability as well as the eradication of poverty. Hence the objectives and purpose of the IDP are:

- ⇒ to provide and ensure sustainable services;
- ⇒ to promote social and economic development;
- ⇒ to promote a safe and healthy environment;
- ⇒ to give priority to the basic needs of communities; and
- ⇒ to encourage involvement/participation of communities.

The integrated development planning approach needs to focus on a consultative/participatory, analytical, strategic and objectives-oriented/event-centered process for decision-making on issues related to municipal development.

BASIC MUNICIPAL PROFILE - Dikgatlong Municipality

Background

The Dikgatlong local municipality is made up of former disestablished municipalities of Barkly West, Windsorton & Delpoortshoop. The municipality derived its name from Setswana word meaning "confluence", and refers to the place where the Harts and Vaal rivers flow into each other in Delpoortshoop. It is situated 30km west of Kimberley the geographical area of the municipality is 2377.6 square kilometres or 19.2% of the district. The population density of the municipality is currently standing at 9.1 people per square kilometer.

Demographic analysis

The municipality is composed of 7 wards with ward 5 and 6 being the biggest in terms of geographical area coverage (1692.53km²) and population (6982 persons) respectively. Ward 1, the smallest ward, covers the geographical area of 0.7801km² and ward 3 has a population of 3582 persons.

The total population of Dikgatlong is estimated at 35765 people (Census, 2001). The estimate indicates that Dikgatlong is the second lowest municipality in the district in terms of the population size. The population represents 11.01% of the total population of the district which is approximately 324 798 persons and 4.4% of the province. The dominant population groups in Dikgatlong are Africans (60.2%) and Colored (32.5%). The other two groups share the remaining 7.3%, with Indians constituting only 0.1% and Whites 7.2%. The province, the district and the municipality have experienced a declining growth rate of -2.09%, -0.22% and -3.21% respectively.

An independent population count commissioned by Urban Dynamic (Independent Consultant) in 2003 the total population was actually found to be 63,258.

The population pyramid of Dikgatlong is distinctive to other municipalities. It indicates a significant number of the economically active group (15 to 64 years) at the top of the pyramid and pensioners (over 65) at the bottom. The economically active group and pensioners constitute 63.1% and 5.1% respectively. The remaining 31.8 % is comprised of pre-school and school going population.

With the inclusion of Sydney-on-Vaal, Vaalbos and Pniel the geographic size of the municipality has increase considerably.

Socio-economic development

The unemployment rate in Dikgatlong is lower than the province and country; it is currently estimate at 27.5% and 28.2% respectively. However, the statistics indicates that the unemployment in Dikgatlong has increased by 1.4% since 1996. Of the 22581 persons falling under the economically active group, only 26.2% are employed. This can be partly attributed to the lack of basic education and basic skills. A third or 32.1% of the educable population (5 to 65 years) have no schooling or some primary schooling.

Unlike Magareng and FBDM, whereby community and social sectors provide work to more than a quarter of the currently employed people, in Dikgatlong, 26.2% of the employed portion of the labor force is mainly employed by Agriculture and Mining sectors.

Furthermore, over 60% (25494) of the population of the area have no income and only 28.7% have income. Of the 28.7% 9271 persons earn less than R3200 per month.

Social Services

- **Housing**

The population of the municipal area lives in three different types of dwellings; formal, informal and traditional. The formal dwelling constitutes of 6793 households which is 71.9% of the total number of households in the area. This is slightly lower than the district and Magareng, which have 80% and 78.9% respectively. More than a tenth (12.8%) of the households resides in informal and traditional houses. Each household has an average of 3.8 people.

- **Electricity**

More than half (62.5%) of the total number of the households in the area use electricity as a source of lighting. The remainder of the households (32%) use candles and 5.5 % use either solar, gas, or paraffin.

- **Sanitation**

The sanitation facilities of Dikgatlong are of acceptable standards. Bucket eradication is in process and will be phased by the end of June 2007.

- **Water**

Over 90% have direct access to water; this is either water in the house or on site. Community stand pipes provide water to about 1821 households (19.3%). 10% of the households are still using unacceptable water sources.

- **Telephone**

About a tenth (10.2%) of the population does not access to telephones. This number has been drastically decreased by almost 20% since 1996. However, a significant number 3760 (39.9%) of households have access to public telephones. The remaining half of the households have access to telephones in the house, use cellular phones or neighbour's phones.

- **Refuse**

According to the Integrated Waste Management Plan, Dikgatlong municipality generates approximately 21.6 tonnes of waste per day. The collection of this waste to 5632 households is done on weekly basis. Of the total of households (9439) in the municipality only 1189 have no access to the waste collection and disposal system. These are mainly households in the rural areas or unserved area within the jurisdiction of the municipality. All refuse sites are fenced and the registration is in process.

METHODOLOGY

The methodology outlined in the IDP GUIDE PACK (Guide I – IV) was used as guideline during the IDP planning process

This chapter deals with the different steps in events followed for the IDP for local Municipalities. It specifically deals with the way in which the municipalities completed its activities within the different phases of the IDP process. The chapter also makes provision for self-assessment of the way in which the methodology complies with the process and procedures described in the process plan.

PROCESS-PLAN

The process plan was adopted by Council on _____ with resolution no _____ and is attached hereto as **Annexure A**.

Although the intention of the process plan was to effectively guide the formulation of the IDP, several changes were made during the formulation process.

Phase I - Analyses

This phase of the IDP is regarded as the platform of existing trends and current realities within the municipality's area where communities and stakeholders were given an opportunity to analyze their problem and determine their priorities.

The main purpose was to form an understanding of the dynamics influencing development within the framework of the community's priority needs and knowledge in respect of available resources.

Based on the outputs from the different analysis as described above, several priority issues were identified aimed at giving direction to the remaining phases of the IDP.

The above process assisted the municipality in drawing an existing development profile of the area as well as arriving at a strategic and implementation oriented decision in respect of development priorities.

Phase II - Strategies

Following the above a set of localized strategy guidelines were formulated in conjunction with guidance of the PGDS. Alternative strategies were then dissolved during the ward based meetings referred to under **Phase IV - Approval**.

Phase III - Projects

The purpose of this phase was to create smooth and effective planning.

The following aspects were considered during project design:

- project objectives and performance indicators
- projects outputs, targets and locations
- major activities, responsibilities and timing
- Internal and external budget estimates and sources for funding

Phase IV - Integration

During this phase the Municipality had to ensure that projects were in line with the agreed vision, objectives and strategies. Most of the sector plans and relevant programmes have been completed and their relevance and status are indicated below:

Phase V - Approval

During this phase the first step was to interact with stakeholders from the different wards in Dikgatlong Municipality Boundaries. Through this interactions the processes and achievements over the past five years (2001 -2005) was explained.

After the ward based meetings an IDP- REP Forum meeting was held on 13/12/2006 which was attended by 43 members, representing different structures within the municipality.

The forum after thorough deliberation and exchange of different views agreed on the following priority issues:
